Dallas Creek Water Company, Inc. proposes the following rate changes that will become effective on June 1, 2022. After filing Advice Letter No. 8, DCWC became aware of formatting errors in certain headers and footers of the proposed tariff pages filed on April 29, 2022. The proposed rate changes will affect the residential, commercial, and utility customers within the Company's PUC approved service area.
